(The total amount of interest earned in 2016 was \$5,054.31; 2015 was \$3,982.65; 2014 was \$3,650.29) That is the totality of the interest report.

B. Title I Grant Director Report – Jill Staggs

In the same light, I would also like for Mrs. Staggs to address the Board and the public regarding our Title 1 grant...a grant in the past which has given us over \$350,000 for extra services. We've experienced a financial cut in this particular area.

Mrs. Staggs updated the Board on the Title I program.

C. District Financial Update

Our 1782 Notice has been received from the Division of Local Government Finance. I have included a copy for each board member here this evening. If you will remember, our advertised tax rate on the 2018 budget was \$1.9540 on an Assess valuation of \$270,000,000. The 1782 has been returned with a tax rate of \$1.0370 on an Assessed Valuation of \$338,809,829

We have talked a couple of times with this Board regarding the legislative action that is dropping the Farmland Assessed Valuation over the course of the next three years. From last year to this year, our District Assessed Valuation has dropped from \$347,099,747 to just over \$338,809,000. Every time our AV goes down, our local tax rate goes up. With 81% Farmland in our district, we are looking at roughly a 27% drop in AV up to 2021
