

In exchange for the Teacher's services described below, the Corporation and the Teacher agree that:



The following are in addition to the regular teacher's contract compensation in the employment of the superintendent:

\*The superintendent shall be valuated one time per year not to occur later than the public session of the November board meeting. The instrument utilized shall be the recommended instrument for superintendent evaluation issued by the Indiana Department of Education.

\*The superintendent was secured and continues to be on an "evergreen" contract, meaning that the contract is automatically renewed to the optimal length of the contract. Should the Board opt not to roll over the contract, the superintendent should be notified in writing by December 15<sup>th</sup> along with the reasons for the action along with job improvement goals and opportunities for improvement.

\*The contract is a 260 day annual workday contract with three weeks of vacation.


\*The superintendent will receive 17 leave days (combination sick leave and personal days).

\*The superintendent will be allowed to transfer all existing sick days, if applicable.

\*The superintendent will receive a fully paid family health insurance, dental insurance, and vision insurance plan.

\*The superintendent will be compensated for mileage at the federal rate.
